for a Community Affairs and Resourcing Management (CARM) Agreement incorporating a Community Contribution with

Leigh Creek Residents and Ratepayers Association Inc.

To be read in conjunction with the Authority's Community Affairs Resourcing and Management Agreement Policy and Procedures and Community Contribution Scheme Policy and Procedures

CARM Component

The Authority is entering a MOU with Leigh Creek Residents and Ratepayers Association Inc., ABN 37 418 664 998 for the purpose of providing support for the Association's Community Affairs and Resourcing Management.

^{*}This excludes OCA's 50% contribution to the insurance policy premium negotiated by the Leigh Creek Residents and Ratepayers Association Inc. with Local Government Risk Services Insurance (LGRS). OCA will pay LGRS the total premium cost and forward an invoice to the Association for 50% of the total premium. The Association will pay this invoice within the financial year to which this MOU applies.

Community Contribution

The Community Contribution is implemented pursuant to Section 21 of the *Outback Communities* (Administration and Management) Act 2009 and in accordance with the Local Government Act 1999 (LG Act).

For the 2024/25 financial year the fixed charge per property unit (after community consultation and Ministerial approval) will be \$927 per property unit on rateable land within the township of Leigh Creek.

The Authority will transfer the entire remaining balance of community contributions collected after expenses, to the Leigh Creek Residents and Ratepayers Association Inc., at the end of the financial year for which this MOU relates.

In signing this MOU, the Leigh Creek Residents and Ratepayers Association Inc. acknowledges the requirement of the CARM Policy and Procedures to provide the OCA with independently reviewed financial statements for the prior financial year by the end of January.
