### 6.2 <u>Small Projects Funding – Projects for Approval</u> (Ref. N24-02/09)

The first round of Small Project Funding 2024-25 was available for submissions until 31 August 2024. Nine applications were received however one submission was deemed more suitable as sponsorship and two submissions require further information and will need to be discussed with the Director.

The remaining six project submissions totalling \$66,424 have been assessed by OCA staff as having merit and are tabled for review by the Board in accordance with Section 9 of the *Outback Communities (Administration and Management) Act 2009* (the Act).

The Outback Communities Authority approves expenditure of \$66,424 on the six recommended Small Projects according to Section 9 of the Act.

## 6.3 Additional 2024-25 CARM Allocations (Ref. N24-03/09)

The Authority previously considered CARM funding requests at their June 2024 meeting.
