

Leigh Creek Demolition Areas – Salvage Items

Dear community members and interested stakeholders

The state government is committed to Leigh Creek becoming a sustainable and open town and a thriving regional tourist hub, and service centre for surrounding northern Flinders Ranges communities.

The transformation process includes the demolition of houses in line with new Town Plan. Local and regional community members have requested the opportunity to purchase salvage items from the proposed demolition zones at Leigh Creek.

The Leigh Creek Task Force has developed the following cost-recovery process which aims for the safe removal of identified salvage items and with fair sale opportunities. The process is explained as below:

Salvage materials - sale process principles

1. Community members will have the ability to bid for salvage items:
 - a. Items will be removed by a qualified contractor that will be engaged by the Department for Infrastructure and Transport.
 - b. Minimum cost/ bids must be equal to or greater than the cost of removing the item from the property and getting the item ready for sale and collection.
 - c. Items will be sold as is, with no guarantee as to quality or fit for purpose (buyer beware).
 - d. Items must be collected by the purchaser; delivery is not included.
 - e. Any profits will be redirected to the Leigh Creek community (process to be advised if applicable).

2. Process for purchasing salvage:
 - a. Community members can review the table below and select any items from the residential demolition area they would wish to purchase (minimum price of items will be at cost).
 - b. Community members can also advise of any items they would wish to purchase (minimum price of items will be at cost) from a non-residential demolition area. Availability will be subject to an assessment of whether these items can be safely removed.
 - c. Please email Tracy Neldner at Tracy.Neldner@sa.gov.au or phone 0886752126 with your contact details and the specific item(s) that you are interested in by **5.00pm on Friday, 14 May 2021**.
 - d. A list of items where interest has been shown will be compiled for a contractor to price up removing the items from the demolition areas and making available for collection.
 - e. The contractor may consider an item(s) cannot be safely removed. Interested parties will be notified and will have the opportunity to bid on an alternative item.
 - f. For those that have registered their interest, an auction will be held at the earliest date (to be advised). This process will be ensure that where there is more than one person's interest in an item, it will be sold fairly.
 - g. Items must be purchased and paid for prior to removal. A timeline for payment will be provided as soon as practical.
 - h. Details for collection of your salvage item purchases will be advised following payment.

Salvage items – available for purchase (by item number/ address)

1. Items that are in reasonable condition from the residential demolition area have been identified as per the table below.
2. Should you wish to apply the salvage process to an item in a non-residential demolition area, please advise. Availability will be subject to an assessment of whether these items can be safely removed.
